Donations are not only collected to fund new endeavours for the College such as the recently announced Residences building or the Gary W Harris Canada Winter Games Centre but also to raise money for awards and scholarships. In the past the Students' Association has contributed to renovation of the Library, as a recognition we expanded the Far Side Bar & Grill and our own building. The SA has an endowment fund to provide students with many awards and scholarships, and more recently the SA made a donations to the Gary W Harris Canada Winter Games Centre and as recognition the College will renovate the Train Station to suit the needs of the students at the discretion of the Students' Association. Donors have the ability to apply limitations on what the intention for their donation is, such as a specific award, school, new structure or renovation on campus, etc.

Recently the College has reached a milestone of distributing \$1,000,000 of scholarships in one year. Awards and scholarships requirements have been adjusted to make them more attainable to more students, so now most students would be eligible for more.

Michael spoke on the Gary W Harris Canada Winter Games Centre and showed a few videos sharing the progress of the new Centre. The College is hoping to be moving in furniture in June and will be hosting a grand opening in August. The SA will be doing 2 tours in the new year of the new space. Michael touched on some of the many features of the building as well as the features of the new residence building that recently broke ground.
